ACTUARIAL EQUIVALENT OF THAT AMOUNT, IN THE SAME MANNER AS THE BENEFIT OTHERWISE PAYABLE UNDER THIS PENSION SYSTEM.

- (B) CONTRIBUTIONS SHALL BE MADE ON AND AFTER THE DATE OF ESTABLISHMENT AT THE RATE OF 5 PERCENT OF THE PART OF THE MEMBER'S EARNABLE COMPENSATION THAT IS IN EXCESS OF THE TAXABLE WAGE BASE FOR EACH YEAR. EACH OF THE AMOUNTS SHALL BE:
- (I) DEDUCTED UNTIL THE MEMBER RETIRES OR OTHERWISE WITHDRAWS FROM SERVICE;
  - (II) PAID INTO THE ANNUITY SAVINGS FUND;

AND

(III) CREDITED TO THE INDIVIDUAL ACCOUNT OF

THE MEMBER.

- EVERY MEMBER SHALL BE DEEMED TO CONSENT (C) DEDUCTIONS MADE AND PROVIDED HEREIN AND SHALL RECEIPT THE FOR HIS FULL COMPENSATION, AND PAYMENT OF COMPENSATION LESS SUCH DEDUCTION SHALL BE A FULL AND COMPLETE DISCHARGE AND ACQUITTANCE OF ALL CLAIMS AND DEMANDS WHATSOEVER FOR SERVICES RENDERED BY SUCH PERSON DURING THE PERIOD COVERED BY SUCH PAYMENT. ANY DEPARTMENT THAT FAILS TO PAY TO THIS PENSION SYSTEM THE DEDUCTIONS FROM THE COMPENSATION OF ITS EMPLOYEES ON THE DATE THE EMPLOYEES ARE PAID SHALL BE LIABLE FOR A PENALTY OF 10 PERCENT OF THE AMOUNTS DUE. HOWEVER, SECRETARY OF THE BOARD MAY ALLOW A GRACE PERIOD NOT TO EXCEED 10 ADDITIONAL CALENDAR DAYS. ALL AMOUNTS UNPAID ON THE DATE OF PAYMENT SHALL ALSO BEAR INTEREST AT THE RATE OF 10 PERCENT A YEAR UNTIL THE DATE OF PAYMENT. STATE COMPTROLLER, IF NOTIFIED BY THE SECRETARY THAT A DELINQUENCY EXISTS, SHALL IMMEDIATELY EXERCISE THE RIGHT OF AGAINST ANY MONEY DUE OR TO BECOME DUE TO THE DELINQUENT DEPARTMENT.
- (D) SUBJECT TO THE APPROVAL OF THE BOARD TRUSTEES, IN ADDITION TO THE CONTRIBUTIONS DEDUCTED FROM EARNABLE COMPENSATION AS PROVIDED IN THIS SECTION, ANY MEMBER MAY DEPOSIT THEREIN BY SINGLE PAYMENT OR BY AN INCREASED RATE OF CONTRIBUTION AN AMOUNT COMPUTED TO BE SUFFICIENT TO PURCHASE AN ADDITIONAL ANNUITY WHICH, TOGETHER WITH HIS PROSPECTIVE RETIREMENT ALLOWANCE, WILL PROVIDE FOR HIM A TOTAL RETIREMENT ALLOWANCE NOT IN EXCESS OF TWO-THIRDS OF HIS AVERAGE FINAL COMPENSATION AT THE AGE OF 62. ADDITION TO THE CONTRIBUTIONS PROVIDED FOR IN THIS SECTION, SUBJECT TO THE CONDITIONS ESTABLISHED BY THE BOARD OF TRUSTEES, ANY ELIGIBLE MEMBER, IN ACCORDANCE WITH A CONTRACT WITH HIS EMPLOYER, MAY HAVE FURTHER CONTRIBUTIONS AT A FIXED PERCENTAGE OF 2 PERCENT OR MORE, BUT NOT TO EXCEED 20 PERCENT OF HIS COMPENSATION MADE ON HIS ACCOUNT, EITHER BY A REDUCTION IN HIS SALARY OR INSTEAD OF AN INCREASE COMPENSATION. THE COST OF ADMINISTERING ANNUITIES THAT QUALIFY UNDER § 403(B) OF THE INTERNAL REVENUE CODE AS AMENDED FROM TIME TO TIME, SHALL BE PROVIDED FROM THE FUNDS INVESTED IN THESE ANNUITIES.
