- (b) Interests in corporation. —A schedule of all interests in any corporation, whether or not the corporation does business with the State. This schedule, as to each such interest, shall include:
- (1) The name and address of the principal office of the corporation;
- (2) The nature and amount of the interest held, including any conditions thereto and encumbrances thereon; provided, however, that an amount of stock or like evidence of equity interest, at the option of the person making the report, may be reported by the number of shares held and, unless the corporation's stock is publicly traded on a stock exchange, in an over-the-counter market, or otherwise, the percentage of equity interest so held, instead of by dollar amount; [and]
- (3) With respect to any interest transferred, in whole of OR in part, at any time during the year for which the statement is filed, a description of the interest transferred, the nature and amount of the consideration received in exchange therefor and, if known, the identity of the person to whom the interest was transferred[.]; AND
- (4) WITH RESPECT TO ANY INTEREST ACQUIRED AFTER APRIL 15, 1974:

- (c) Interests in other business entity doing business with State. —A schedule of all interests in any other business entity which does business with the State. This schedule, as to each such interest, shall include:
- (1) The name and address of the principal office of the business entity;
- (2) The nature and amount of the interest held, including any conditions thereto and encumbrances [thereon]; and
- (3) With respect to any interest transferred, in whole or in part, at any time during the year for which the statement is filed, a description of the interest transferred, the nature and amount of the consideration received in exchange therefor and the identity of the person to whom the interest was transferred[.]; AND
