MEMBERS OF MARYLAND-NATIONAL CAPITAL PARK AND PLANNING COMMISSION, WASHINGTON SUBURBAN SANITARY COMMISSION AND WASHINGTON SUBURBAN TRANSIT COMMISSION.

- (A) FOR PURPOSES OF THIS SECTION, THE FINANCIAL DISCLOSURE STATEMENT REQUIRED UNDER TITLE 3 SHALL, WHERE REFERENCING "BUSINESS WITH THE STATE" AND "EMPLOYED BY THE STATE," BE DEEMED TO MEAN "BUSINESS WITH THE STATE, COMMISSION, MONTGOMERY COUNTY, AND PRINCE GEORGE'S COUNTY" AND "EMPLOYED BY THE STATE, COMMISSION, MONTGOMERY COUNTY, AND PRINCE GEORGE'S COUNTY," RESPECTIVELY. THIS STATEMENT SHALL BE FILED UNDER OATH OR AFFIRMATION.
- (B) EACH COMMISSIONER OF THE MARYLAND-NATIONAL PARK AND PLANNING COMMISSION, THE WASHINGTON CAPITAL SUBURBAN SANITARY COMMISSION, OR, IF APPOINTED MONTGOMERY COUNTY OR PRINCE GEORGE'S COUNTY, THE WASHINGTON SUBURBAN TRANSIT COMMISSION, SHALL FILE WITH THE ADMINISTRATIVE OFFICER OF THE COUNTY FROM WHICH THE COMMISSIONER IS APPOINTED, ON OR BEFORE THE 15TH DAY OF APRIL OF EACH YEAR DURING THAT COMMISSIONER'S TERM IN OFFICE, THE STATEMENT SET FORTH IN SUBSECTION (A) CALENDAR YEAR IMMEDIATELY PRECEDING EACH SUCH YEAR IN OFFICE.
