FOR the purpose of extending to governmental entities the air quality control provisions; requiring adoption of certain rules and regulations for payment of certain costs, as a condition for permits; enabling the Secretary of Health and Mental Hygiene to adopt certain other rules and regulations for air pollution control requirements and for penalty assessments; providing for additional penalties for failure to pay the fees and for enforcement of the rules and regulations; providing for the dispositions of certain funds; clarifying certain language; and generally relating to air quality.
