(E) SCHITHSTANDING ANY PROVISION OF A GROUP OF INDEVIOUAL POLICY -OR CONTRACT, OR ANY CERTIFICATE ISSUED THEREURD 82, OF UNALTRY SICKURGS, ACCUDENT, OR DISABILITY INSURANCE THAY IS HERETERA ON AR EXPENSE INCURRED BASIS, DELIVERED FIRMIN THE STATE ON ISSUED TO A GROUP WHICH IS INCORPORATED OR HAS A MAIN OFFICE LCCATED IN THE STITE. OR COVERING PRESONS WHO PRESIDE OR WOR WITHIN THE STATE, SHENEVER - SUCE-POLICY, CONTRACY, OR CONTRICATE PROVIDES FOR REIMBURSEMENT FOR ANY SERVICE VIICH IS SITHIN THE LAWFUL SCOPE OF PRACTICE OF A NURSE PRACTITIONER, THE INSURED, OR ANY OTHER PESSOR COVERED BY THE POLICY CONTRACT, OR CERTIFICATE, SHALL BE ENTITLED TO BELABURS ZAENT FOR SUCH SERVICE, WHETHER THE SERVICE IS DERFORMED BY A DOCTOR OF MEDICINE OR A NURSE MIDWIFF. THE PROVISIONS OF THIS SECTION SHALL APPLY TO ALL-SUCK POLICIES, CONTRACTS, OR CERTIFICATES ISSUED, RENEWED, MODIFIED, ALTERED, AMENDED, OR RELEGUED ON OR AFTER JULY 1, 1980.

- (A) IN THIS SECTION "CERTIFIED NURSE PRACTITIONER"
 MEANS A LICENSED REGISTERED NURSE WHO HAS COMPLETED A NURSE
 PRACTITIONER PROGRAM APPROVED BY THE MARYLAND STATE BOARD OF
 EXAMINERS OF SURSES AND WHO HAS PASSED A BOARD APPROVED
 EXAMINATION, AND HAS BEEN CERTIFIED UNDER THE JOINT
 REGULATIONS OF THE BOARD OF MEDICAL EXAMINERS AND THE BOARD
 OF EXAMINERS OF NURSES.
- (B) AFTER JULY 1, 1980, EVERY GROUP OR BLANKET HEALTH INSURER WHO PROPOSES TO ISSUE, RENEW, MODIFY, ALTER, AMEND, OR REISSUE ANY HEALTH INSURANCE POLICY IN MARYLAND THAT IS WRITTEN ON AN EXPENSE INCURRED BASIS SHALL INCLUDE OFFER THE OPTION OF PROVIDING BENEFITS FOR EXPENSES ARISING FROM CARE, TREATMENT, OR SERVICES RENDERED BY A CERTIFIED NURSE PRACTITIONER. THE GROUP OR BLANKET HEALTH INSURER MAY LIMIT THE COVERAGE OFFERED TO FOR THOSE SERVICES PROVIDED BY A NURSE PRACTITIONER WHO WORKS WHILE WORKING DIRECTLY UNDER THE SUPERVISION OF A PHYSICIAN.
- (C) AFTER JULY 1, 1980, A GROUP OR BLANKET HEALTH INSURER SHALL RENEW, MODIFY, ALTER, AMEND, OR REISSUE ANY EXISTING HEALTH INSURANCE POLICY THAT IS WRITTEN ON AN EXPENSE INCURRED BASIS TO INCLUDE OFFER THE OPTION OF PROVIDING BENEFITS FOR EXPENSES ARISING FROM CARE, TREATMENT, OR SERVICES RENDERED BY A CERTIFIED NURSE PRACTITIONER. THE GROUP OR PLANKET HEALTH INSURER MAY LIMIT THE COVERAGE OFFERED TO FOR THOSE SERVICES PROVIDED BY A NURSE PRACTITIONER WHO FORKS WHILE WORKING DIRECTLY UNDER THE SUPERVISION OF A PHYSICIAN.
- (D) UTILIZATION OF GROUP OR BLANKET HEALTH INSURANCE BENEFITS BY A CERTIFIED NURSE PRACTITIONER IS SUBJECT TO REVIEW BY A PEER REVIEW COMMITTEE APPOINTED BY THE STATE BOARD OF EXAMINERS OF NURSES IN ACCORDANCE WITH THE JOINT PEGULATIONS OF THE BOARD OF MEDICAL EXAMINERS AND THE BOARD OF EXAMINERS OF NURSES.
