THE RECORDS RESULTS IN ANY MEMBER OR BENEFICIARY RECEIVING FROM THIS PENSION SYSTEM MORE OR LESS THAN HE WOULD HAVE BEEN ENTITLED TO RECEIVE HAD THE RECORDS BEEN CORRECT, THE BOARD OF TRUSTEES SHALL:

# (1) CORRECT THE ERROR; AND

(2) AS FAR AS PRACTICABLE, ADJUST THE PAYMENT IN A MANNER THAT THE ACTUARIAL EQUIVALENT OF THE BENEFIT TO WHICH THE MEMBER OR BENEFICIARY WAS CORRECTLY ENTITLED SHALL BE PAID.

### 127. LIMITATION ON MEMBERSHIP.

ANY OTHER LAW THAT PROVIDES WHOLLY OR PARTLY AT THE EXPENSE OF THE STATE OF MARYLAND FOR PENSIONS OR RETIREMENT BENEFITS FOR EMPLOYEES OF THE STATE, THEIR SURVIVING SPOUSES, OR OTHER DEPENDENTS, DOES NOT APPLY TO MEMBERS OR BENEFICIARIES OF THIS PENSION SYSTEM, THEIR SURVIVING SPOUSES, OR OTHER DEPENDENTS, EXCEPT BENEFITS FROM SOCIAL SECURITY. THIS SECTION DOES NOT APPLY TO ANY PERSON WHOSE PENSION OR RETIREMENT ALLOWANCE WAS ESTABLISHED UNDER OTHER LAW AND TO WHICH THE STATE DOES NOT CONTRIBUTE, AND IT DOES NOT APPLY TO THE BENEFICIARIES OF THAT PERSON.

#### 128. POST COMPLIANCE AUDITS.

AT HIS DISCRETION THE LEGISLATIVE AUDITOR MAY CONDUCT AN ANNUAL AUDIT OF A FISCAL AND COMPLIANCE NATURE OF THE ACCOUNTS AND TRANSACTIONS OF THE EMPLOYEES' PENSION SYSTEM IN PLACE OF CONDUCTING THESE AUDITS ON A BIENNIAL BASIS. OFFICIALS OF THE EMPLOYEES' PENSION SYSTEM SHALL BE ADVISED WHETHER ANNUAL OR BIENNIAL AUDITS WILL BE CONDUCTED.

#### 129. PRERETIREMENT COUNSELING SERVICE.

ALL STATE EMPLOYEES UNDER THIS PENSION SYSTEM SHALL BE PROVIDED WITH A PRERETIREMENT COUNSELING SERVICE REGARDING PENSION BENEFITS. WITH THE CONSENT OF THE RETIREE, THE COUNSELING ALSO SHALL BE AVAILABLE TO HIS SPOUSE OR MEMBERS OF HIS IMMEDIATE FAMILY.

## 130. DEFINITIONS.

- (1) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANING INDICATED.
- (2) (A) "MUNICIPAL CORPORATION" MEANS A COUNTY, INCORPORATED TOWN, OR MUNCIPALITY OR SPECIAL TAXING AREA, OR ANY OTHER POLITICAL SUBDIVISION OF THE STATE.
- (B) "MUNICIPAL CORPORATION" INCLUDES ANY PUBLIC LIBRARY ASSOCIATION OR ORGANIZATION, ANY FIRE DEPARTMENT THAT RECEIVES PART OR ALL OF ITS FUNDS FROM OR THROUGH ANY COUNTY, TOWN, MUNICIPALITY, SPECIAL TAXING AREA, OR OTHER POLITICAL SUBDIVISION OF THE STATE, AND ANY BOARD OR COMMISSION CREATED BY AN ACT OF THE GENERAL ASSEMBLY FOR
