- (A) A LICENSED DENTIST MAY NOT HOLD HIMSELF OUT TO THE PUBLIC AS A SPECIALIST IN ANY FIELD OF DENTISTRY UNLESS HE IS IDENTIFIED AS A SPECIALIST BY THE BOARD.
- (2) (B) A LICFNSED DENTIST IS CONSIDERED TO HOLD HIMSELF OUT TO THE PUBLIC AS BEING ESPECIALLY QUALIFIED IN A BRANCH OF DENTISTRY AS A SPECIALIST IF HE ANNOUNCES HIS DENTAL PRACTICE BY CARD, LETTERHEAD, DIRECTORY LISTINGS, OR OTHER PRINTFD MANNER, USING SUCH TERMS AS "SPECIALIST," "PRACTICE LIMITED TO...," "SPECIAL ATTENTION TO...," "LIMITED TO SPECIALTY OF...," OR EQUIVALENT WORDS OR PHRASES, AND DESIGNATES ONE OR MORE SPECIALTIES.
- (E) A LICENSED DENTIST WHO MEETS THE QUALIFICATIONS
 FOR SPECIALIZED DENTAL PRACTICE ESTABLISHED BY THE BOARD
 SHALL USE THE PHRASE "PRACTICE LIMITED TO..." AND NO OTHER
 PHRASE, IN CARDS, LETTERHEADS, DIRECTORY LISTINGS, AND OTHER
 PPINTED MATTER, OR SIGNS WHICH REFER TO HIS SPECIALIZATION.
- (C) A LICENSED DENTIST WHO IS IDENTIFIED AS A SPECIALIST BY THE BOARD SHALL USE ONLY LANGUAGE APPROVED BY THE BOARD IN ANY CARDS, LETTERHEADS, DIRECTORY LISTINGS, SIGNS, OR OTHER PRINTED MATTER WHICH REFER TO HIS SPECIALIZATION.
