

COMMISSIONERS OF THE COUNTY (THE "BOARD") TO ADOPT A RESOLUTION IN ACCORDANCE WITH SECTION 15(4) OF ARTICLE 25B OF THE ANNOTATED CODE OF MARYLAND (1973 REPLACEMENT VOLUME), AS AMENDED; AUTHORIZING AND EMPOWERING THE BOARD BY SUCH RESOLUTION (1) TO PRESCRIBE THE FORM, TENOR, TERMS AND CONDITIONS OF AND SECURITY FOR THE BONDS, (2) TO PRESCRIBE THE AMOUNTS, DATE, MATURITY OR MATURITIES, INTEREST RATE OR RATES, SINKING FUND REQUIREMENTS (IF ANY), AND REDEMPTION PROVISIONS OF THE BONDS, (3) TO APPOINT A TRUSTEE, A BOND REGISTRAR AND A PAYING AGENT OR AGENT FOR THE BONDS, (4) TO APPROVE THE FORM AND CONTENTS, AND TO AUTHORIZE THE EXECUTION AND DELIVERY (WHERE APPLICABLE) OF (A) A LOAN AGREEMENT BETWEEN THE COMPANY AND THE COUNTY, (B) A TRUST AGREEMENT BETWEEN THE COUNTY AND THE TRUSTEE APPOINTED HEREUNDER, AND (C) SUCH OTHER DOCUMENTS, INCLUDING (WITHOUT LIMITATION) MORTGAGES, DEEDS OF TRUST, GUARANTIES AND SECURITY INSTRUMENTS AS THE BOARD SHALL DEEM NECESSARY TO EFFECTUATE THE ISSUANCE, SALE AND DELIVERY OF THE BONDS, (5) TO DETERMINE THE TIME OF ISSUANCE, SALE AND DELIVERY OF THE BONDS AND TO PRESCRIBE ANY AND ALL OTHER DETAILS OF THE BONDS, (6) TO PROVIDE FOR THE DIRECT PAYMENT BY THE COMPANY OF ALL COSTS, FEES AND EXPENSES INCURRED BY OR ON BEHALF OF THE COUNTY IN CONNECTION WITH THE ISSUANCE, SALE AND DELIVERY OF THE BONDS, (7) TO PROVIDE FOR THE ISSUANCE AND SALE (SUBJECT TO THE ENACTMENT BY THE BOARD OF SUCH LEGISLATION AS IS REQUIRED AT THE TIME) OF ONE OR MORE SERIES OF ADDITIONAL BONDS AND ONE OR MORE SERIES OF REFUNDING BONDS, AND (8) TO DO ANY AND ALL THINGS, AND TO AUTHORIZE THE OFFICIALS OF THE COUNTY TO DO ANY AND ALL THINGS, NECESSARY, PROPER OR EXPEDIENT IN CONNECTION WITH THE ISSUANCE, SALE AND DELIVERY OF THE BONDS; EXEMPTING THE BONDS FROM THE PROVISIONS OF SECTIONS 9 TO 11, INCLUSIVE OF ARTICLE 31 OF THE ANNOTATED CODE OF MARYLAND (1976 REPLACEMENT VOLUME), AS AMENDED; AND GENERALLY PROVIDING FOR AND DETERMINING VARIOUS MATTERS IN CONNECTION WITH THE AUTHORIZATION, ISSUANCE, SECURITY, SALE AND PAYMENT OF THE BONDS.
