

- (1) PROTECT-THE-COMPLAINANT-FROM-FURTHER--HARM;
- (2) ADVISE-THE--COMPLAINANT--OF--ALL--AVAILABLE SOURCES--OF-SHELTER, MEDICAL-CARE, COUNSELING, AND-SERVICES;
- (3) TRANSPORT---THE---COMPLAINANT---TO---SUCH FACILITIES-AS-APPROPRIATE;
- (4) ACCOMPANY-THE--COMPLAINANT--TO--THE--FAMILY HOME--SO--THAT--THE--COMPLAINANT-MAY-REMOVE-PERSONAL-PROPERTY THAT-IS-REASONABLY-NECESSARY-IN-ORDER--FOR--THE--COMPLAINANT AND--ANY-CHILDREN-WHO-WERE-RESIDING-WITH-THE-PARTIES-AND-ARE PRESENTLY-IN-THE-CARE-OF-THE-COMPLAINANT-TO-REMAIN-ELSEWHERE PENDING-FURTHER-PROCEEDINGS.

(c) IF--A--COMPLAINANT--DESCRIBED--IN--(B)--HAS--BEEN REFUSED--ENTRY--TO--THE--FAMILY--HOME--OR-IF-THE-COMPLAINANT REASONABLY-BELIEVES-AN-ATTEMPT-TO-RETURN-TO-THE-FAMILY--HOME WOULD--BE-REFUSED-BY-THE-OTHER-SPOUSE, THE-COMPLAINANT, WITH OR-WITHOUT-THE-ASSISTANCE-OF-COUNSEL, MAY-COMPLETE--A--SWORN PETITION--AT--THE--LOCAL-LAW-ENFORCEMENT-AGENCY,--A-SUITABLE FORM-SHALL-BE-MADE-AVAILABLE-BY-ALL-LAW-ENFORCEMENT-AGENCIES AND-SHALL-CONTAIN-THE-FOLLOWING-INFORMATION--TO--THE-EXTENT POSSIBLE:

- (1) THE-NAMES, HOME--AND--WORK--ADDRESSES,--AND TELEPHONE-NUMBERS-OF-BOTH-SPOUSES;
- (2) THE-NAMES, AGES, AND-PRESENT-WHEREABOUTS-OF ALL-CHILDREN-RESIDING-WITH-THE-PARTIES;
- (3) THE-LOCATION-OF-THE--FAMILY--HOME--AND--THE MANNER-IN-WHICH-IT-IS-TITLED, HELD, OR-LEASED;
- (4) A-STATEMENT-OF-THE-FACTS-AND--CIRCUMSTANCES OF--THE--SPOUSAL--VIOLENCE--ON-THIS-OR-OTHER-OCCASIONS-WHICH LEAD-THE-PETITIONER-TO-BELIEVE-THERE-IS-A-DANGER-OF--SERIOUS AND-IMMEDIATE-HARM-TO-THE-PETITIONER-OR-OTHERS,--AND-THAT-THE EMERGENCY-ASSISTANCE-OF-THE-COURT-IS-NECESSARY;
- (5) AN-AFFIDAVIT--UNDER--PENALTIES--OF--PERJURY THAT-THE-FACTS-AND-ALLEGATIONS-CONTAINED-IN-THE-PETITION-ARE TRUE---TO---THE---BEST---OF---THE---PETITIONER'S--KNOWLEDGE, RECOLLECTION, AND-BELIEF.

(D) THE-PETITION-SHALL-BE-PRESENTED-AT--THE--EARLIEST POSSIBLE--TIME--TO--THE--JUDGE--OF--A-COURT-FOR-AN-IMMEDIATE REVIEW---THE-REVIEWING-JUDGE-MAY-ORDER:

- (1) THAT-THE-PETITIONER-BE-ALLOWED-TO-RETURN-TO THE-FAMILY-HOME-IN-THE-COMPANY-OF-A-LAW-ENFORCEMENT-OFFICER, ENTER-THE-DWELLING, WITH-OR-WITHOUT-THE--PERMISSION--OF--THE OTHER--SPOUSE--BUT--IN-AS-PEACEFUL-A-MANNER-AS-POSSIBLE, AND REMOVE-PERSONAL-PROPERTY-THAT--IS--REASONABLY--NECESSARY--IN ORDER--FOR-THE-PETITIONER-AND-ANY-CHILDREN-WHO-WERE-RESIDING WITH-THE-PARTIES-AND--ARE--PRESENTLY--IN--THE--CARE--OF--THE
