SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That section(s) of the Annotated Code of Maryland be repealed, amended, or enacted to read as follows:

(A-1) (1) IN BALTIMORE CITY, THE BOARD OF LICENSE COMMISSIONERS--MAY--EITHER--SUSPEND--OR-IMPOSE-A-FINE-ON-ANY LICENSEE-WHO-VIOLATES-THE-PROVISIONS-OF-THIS-ARTICLE:

(2)--THE-FINE-FOR-A-FIRST-OFFENSE-IN-VIOLATION-OF THE-PROVISIONS-OF-THIS-ARTICLE-MAY-NOT-EXCEED-5500:

(3)--THE-FINE-FOR-A-SECOND-OFFENSE--IN--VIOLATION OF--THE--PROVISIONS-OF-THIS-ARTICLE-MAY-NOT-EXCEED-\$200-WITH NOT-MORE-THAN-A-5-DAY-SUSPENSION--THE-LIGENSEE--MAY--CHOOSE THE--5--DAY--PERIOD--OF--SUSPENSION--WITHIN--15--DAYS-OF-THE VIOLATION.

(4)--IF-THE-LIGENSEE-VIOLATES-THE-PROVISIONS--OF THIS-ARTICLE-5-OR-MORE-TIMES-IN-A-24-MONTH-PERIOD,-THE-BOARD MAY--REVOKE--THE-LIGENSE-OR-GIVE-THE-LIGENSEE-THE-OPTION-TO SELL-THE-LIGENSE-WITHIN-A-6-MONTH-PERIOD, COMMISSIONERS MAY IMPOSE A FINE OF NOT MORE THAN \$500 OR SUSPEND THE LICENSE OF A LICENSEE FOR ANY VIOLATION THAT IS CAUSE FOR SUSPENSION UNDER THE ALCOHOLIC BEVERAGE LAWS AFFECTING BALTIMORE CITY.
