

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That section(s) of the Annotated Code of Maryland be repealed, amended, or enacted to read as follows:

Article - Transportation

12-104.

(c) (1) The Administration shall maintain as many offices in this State as the Administrator considers necessary to carry out the powers and duties of the Administration. [Each office shall be open daily except, for Saturdays, Sundays, and holidays, during]

(2) EACH OFFICE SHALL BE OPEN ON THE DAYS AND DURING THE HOURS THAT THE SECRETARY DETERMINES ARE NEEDED TO SERVE THE PUBLIC.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect ~~October 1~~ July 1, 1980.
