

COMMISSIONERS IN COMPLYING WITH THE REQUIREMENTS OF
SUBSECTION (D) OF THIS SECTION.

(F) IF THE COUNTY COMMISSIONERS ACT TO ABOLISH AN
EXISTING WATER AND SEWER AUTHORITY, SANITARY DISTRICT, OR
COMMISSION, THE COUNTY COMMISSIONERS SHALL THEN EXERCISE THE
AUTHORITY AND POWERS OF A WATER AND SEWER AUTHORITY,
SANITARY DISTRICT, OR COMMISSION. SUCH POWERS AND AUTHORITY
SHALL INCLUDE, BUT ARE NOT LIMITED TO:

(1) THE ADOPTION OF RULES AND REGULATIONS FOR
WATER AND SEWERAGE MANAGEMENT;

(2) THE ACQUISITION, CONSTRUCTION, OPERATION,
AND MAINTENANCE OF WHATEVER WATER AND SEWERAGE SYSTEMS IT
DEEMS TO BE IN THE PUBLIC INTEREST AND NECESSARY TO PROTECT
THE GENERAL HEALTH AND WELFARE OF THE COUNTY RESIDENTS; AND

(3) THE ESTABLISHMENT OF RATES, FEES AND
ASSESSMENTS FOR WATER AND SEWERAGE SERVICES AND BENEFITS.

~~{D}~~ (G) THE POWERS GRANTED TO COUNTY COMMISSIONERS MAY
BE EXERCISED NOTWITHSTANDING THE EXISTENCE OF ANY PUBLIC
GENERAL LAW OR PUBLIC LOCAL LAW TO THE CONTRARY WHICH IS IN
EXISTENCE AT THE TIME THE COUNTY COMMISSIONERS EXERCISE THE
POWER GRANTED BY THIS SECTION.
