- (3) Each member of the association shall participate in the expenses[,profits] and losses of the association in the proportion that its premiums written bear to the aggregate premiums written by all members of the association.
- (4) The association shall be administered by a governing committee subject to the supervision of the Commissioner. The governing committee [acting as such under the voluntary Maryland property insurance availability program immediately prior to the effective date of this subtitle shall become the first governing committee under this subtitle.
