- list. IN THE EVENT OF A CONSUMER MEMBER VACANCY, THE GOVERNOR SHALL APPOINT A SUCCESSOR TO SERVE THE REMAINDER OF THE UNEXPIRED TERM.
- (c) Members of the Board holding office on July 1, 1975, shall serve the balance of the terms for which they were appointed. In implementation of subsection (a), additional appointments to the Board shall be made as follows:
- (III) THE INITIAL TERM OF ONE CONSUMER MEMBER SHALL BE 2 YEARS, AND THE INITIAL TERM OF THE OTHER CONSUMER MEMBER SHALL BE 3 YEARS.

- (D) EACH CONSUMER MEMBER SHALL:
- (1) BE QUALIFIED--TO-REPRESENT-THE-INTERESTS-OF GONSUMERS MEMBERS OF THE GENERAL PUBLIC;
- (2) NEVER HAVE BEEN A NURSE OR NURSE-IN-TRAINING, NOR HAVE A HOUSEHOLD MEMBER WHO IS A NURSE OR NURSE-IN-TRAINING:
- (3) NEVER HAVE PARTICIPATED IN A RELATED COMMERCIAL OR PROFESSIONAL FIELD, NOR HAVE A HOUSEHOLD MEMBER WHO PARTICIPATES IN A RELATED COMMERCIAL OR PROFESSIONAL FIELD; AND
- (4) HAVE NOT WITHIN 2 YEARS PRIOR TO APPOINTMENT NOR DURING THE TERM OF APPOINTMENT HAD A FINANCIAL INTEREST IN AN INDIVIDUAL, ASSOCIATION, UNINCORPORATED ASSOCIATION, CORPORATION, OR ANY OTHER ENTITY WHICH IS REGULATED BY THE BOARD.
- (E) A CONSUMER MEMBER MAY NOT PARTICIPATE IN ACTIVITIES RELATING TO EXAMINATIONS UNLESS APPROVED BY THE BOARD.

(d) The Board shall meet annually in May and shall elect from its members a president and a secretary who shall also be the treasurer. It shall hold other meetings during the year necessary to transact its business or as requested by the Secretary of Health and Mental Hygiene. [Five] SIX members of the Board including one officer shall constitute a quorum at any meeting. The secretary-treasurer of the Board shall keep a record of all its meetings and a register of the names of all nurses licensed under this subtitle which shall be open to public inspection with adequate restrictions for its safekeeping. He shall give bond in the sum of \$2,000 to the State and shall be responsible for collecting any funds of the Board, and shall also be responsible for certifying the expenses of the members to
