

←++→ (III) PROVIDE A SYSTEM FOR EVALUATION OF THE PROGRAM.

(4) EACH OF THE TWO AREAS OF THIS STATE SHALL BE SERVED BY SEPARATE AND EQUAL COMPONENT PARTS. ONE PART OF THE PROGRAM WILL BE OPERATED IN BALTIMORE CITY AND THE OTHER IN CAROLINE COUNTY.

(B) THE SPECIFIC PURPOSES AND OBJECTIVES OF THIS PROGRAM ARE:

(1) TO DEVELOP AND IMPLEMENT A PROGRAM FOR THE DELIVERY OF SUCH SCHOOL HEALTH SERVICES TO UNDERSERVED SCHOOL-AGE CHILDREN IN TWO AREAS IN THIS STATE AS MAY BE NECESSARY TO ELIMINATE OBSTACLES TO LEARNING;

(2) TO PREPARE HAVE PREPARED TWO REGISTERED NURSES CURRENTLY EMPLOYED IN THE LOCAL HEALTH DEPARTMENT AS PEDIATRIC-SCHOOL NURSE PRACTITIONERS;

(3) TO ASSIGN EACH PEDIATRIC-SCHOOL NURSE PRACTITIONER WITH A HEALTH AIDE TO AN AREA THAT HAS UNDERSERVED SCHOOL-AGE CHILDREN, USING ONE OR MORE SCHOOLS AS THEIR FOCUS; AND

(4) TO UTILIZE DATA GATHERED BETWEEN JULY 1, ~~1980~~ 1981 TO JUNE 30, ~~1982~~ 1983 TO EVALUATE THE EFFICACY OF THE INTERVENTION OF THE PEDIATRIC-SCHOOL NURSE PRACTITIONER IN IMPROVING THE HEALTH AND LEARNING OF CHILDREN IN THE SPECIFIED AREA AS MEASURED BY SELECTED INDICES.

(C) (1) FUNDS FOR THIS PROGRAM SHALL BE USED TO ACQUIRE:

(I) THE SERVICES OF ONE FULL-TIME PEDIATRIC-SCHOOL NURSE PRACTITIONER AND ONE FULL-TIME HEALTH AIDE II FROM THE CAROLINE COUNTY HEALTH DEPARTMENT, BUREAU OF COMMUNITY HEALTH NURSING; AND

(II) THE SERVICES OF ONE FULL-TIME PEDIATRIC-SCHOOL NURSE PRACTITIONER AND ONE FULL-TIME HEALTH AIDE II FROM THE BALTIMORE CITY HEALTH DEPARTMENT, BUREAU OF COMMUNITY HEALTH NURSING.

(2) THE LOCAL SUBDIVISIONS SHALL BE REIMBURSED FOR THE PURCHASE OF NECESSARY SUPPLIES FOR THE PROGRAM.

(3) THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE OR THE BALTIMORE CITY HEALTH DEPARTMENT SHALL DESIGNATE A PART-TIME HEALTH RESEARCH DESIGN ANALYST:

(I) TO PLAN THE DESIGN OF THE PROGRAM;

(II) TO WORK WITH THE LOCAL SUBDIVISIONS TO COLLECT AND ANALYZE DATA DURING THE PROGRAM PERIOD; AND
