- (a) The Maryland Standardbred Race Fund is created, AND THIS FUND SHALL INCLUDE A MARYLAND STANDARDBRED SIRES STAKES PROGRAM. The fund shall be administered by the Commission with the assistance and advice of the committee hereinafter created, and all payments from the fund shall be made by order of the Commission.
