THE SECRETARY SHALL NOTIFY THE APPOINTING AUTHORITY OF THE COMPLAINT AND SHALL PROVIDE AN OPPORTUNITY FOR THE AUTHORITY TO RESPOND TO THE COMPLAINT IN WRITING.

THE SECRETARY SHALL MAKE AVAILABLE TO THE PROSECUTING AUTHORITY ALL PERTINENT EVIDENCE UNDER HIS CONTROL.
