- (A) THE PROVISIONS OF § 534N-1 OF THIS ARTICLE DO NOT APPLY TO:
- (1) ANY ESTABLISHMENT WHICH OFFERS SERVICE AS ITS PRIMARY BUSINESS;
- (2) ANY BUSINESS IF IT DOES NOT HAVE MORE THAN SIX EMPLOYEES ON ANY ONE SHIFT ON SUNDAY. IN ADDITION TO THESE SIX PERSONS THE BUSINESS MAY ALSO HAVE TWO ADDITIONAL PERSONS PERFORMING SECURITY DUTIES:
- CONVICTION OBSERVES A DAY OTHER THAN SUNDAY AS HIS DAY OF REST AND ACTUALLY REFRAINS FROM LABOR OR SECULAR BUSINESS ON THAT DAY, AND WHOSE ESTABLISHMENT IS CLOSED FOR BUSINESS ON THAT DAY. THE TERM "A DAY OTHER THAN SUNDAY" AS USED HEREIN SHALL MEAN ANY CONSECUTIVE 24-HOUR PERIOD;
- (4) INDUSTRIES WHERE CONTINUOUS PROCESSING OR MANUFACTURING IS REQUIRED BY THE VERY NATURE OF THE PROCESS INVOLVED;
- (5) ANY RECREATIONAL ACTIVITIES, SPORTS, AND AMUSEMENTS;
- (6) ANY BATHING BEACH, BATHHOUSE, AMUSEMENT PARK, DANCING SALON, THE SALE OR SELLING OF ANY NOVELTIES, SOUVENIRS, ACCESSORIES, OR OTHER MERCHANDISE ESSENTIAL TO, OR CUSTOMARILY SOLD AT, OR INCIDENTAL TO, THE OPERATION OF THE AFORESAID OCCUPATIONS AND BUSINESSES, AT RETAIL, PICNIC GROVES, AMUSEMENTS, GAMES, AMUSEMENT RIDES, AMUSEMENT DEVICES, ENTERTAINMENTS, SHOWS;
- (7) THE HIRING OR RENTING OF BOATS, TABLES, CHAIRS, BEACH UMBRELLAS;
  - (8) FARMERS;
  - (9) NURSERYMEN: AND
- (10) THE FOLLOWING TYPE OF RETAIL ESTABLISHMENTS:
- THE SALE OF DRUGS AND RELATED ITEMS;
- BUSINESS IS THE SALE OF DELICATESSEN AND RELATED FOOD ITEMS;
  - (III) BAKERIES AND BAKESHOPS;
- (IV) GASOLINE STATIONS WHOSE PRINCIPAL BUSINESS IS THE SALE OF GASOLINE, OIL, AND OTHER AUTOMOBILE MAINTENANCE ITEMS;
- AND (V) RESTAURANTS, GRILLS, AND SNACK BARS;
