

(2) A WHOLESALE OR RETAIL ESTABLISHMENT MAY NOT CAUSE, DIRECT, OR AUTHORIZE ANY EMPLOYEE OR AGENT TO ENGAGE IN OR CONDUCT BUSINESS ON ITS BEHALF ON SUNDAY.

(3) THE STATE'S ATTORNEY OF HOWARD COUNTY MAY PETITION THE CIRCUIT COURT TO ENJOIN ANY VIOLATION OF THIS SECTION.

(C) THIS SECTION DOES NOT AMEND OR APPLY TO ANY EXISTING LAWS PERTAINING TO ALCOHOLIC BEVERAGE SALES OR SERVICE OF PROCESS ON SUNDAYS.

(D) THIS SECTION DOES NOT PERMIT ANY NEW OR USED CAR DEALERS TO SELL, DISPOSE OF, BARTER, DEAL IN, DELIVER, GIVE AWAY, SHOW, OR OFFER FOR SALE ANY MOTOR VEHICLE OR ANY CERTIFICATE OF TITLE FOR ANY MOTOR VEHICLE ON SUNDAY.

(E) (1) ANY PERSON, FIRM, OR CORPORATION VIOLATING THE PROVISIONS OF THIS SECTION IS GUILTY OF A MISDEMEANOR AND, UPON CONVICTION, IS SUBJECT TO THE PENALTIES PROVIDED BY THIS SUBSECTION.

(2) THE FIRST CONVICTION IS PUNISHABLE BY A FINE NOT TO EXCEED AN AMOUNT EQUIVALENT TO \$500 MULTIPLIED BY THE NUMBER OF EMPLOYEES THAT ARE WORKING IN EXCESS OF THE NUMBER PERMITTED UNDER THE PROVISIONS OF THIS SECTION.

(3) THE SECOND CONVICTION IS PUNISHABLE BY A FINE NOT TO EXCEED AN AMOUNT EQUIVALENT TO \$1,000 MULTIPLIED BY THE NUMBER OF EMPLOYEES THAT ARE WORKING IN EXCESS OF THE NUMBER PERMITTED UNDER THE PROVISIONS OF THIS SECTION.

(4) THE THIRD AND ANY SUBSEQUENT CONVICTIONS ARE PUNISHABLE BY A FINE NOT TO EXCEED AN AMOUNT EQUIVALENT TO \$5,000 MULTIPLIED BY THE NUMBER OF EMPLOYEES THAT ARE WORKING IN EXCESS OF THE NUMBER PERMITTED UNDER THE PROVISIONS OF THIS SECTION.

(5) NOTHING CONTAINED IN THIS SECTION SHALL BE CONSTRUED TO PERMIT ANY FINE UPON ANY EMPLOYEE OR AGENT WHO HAS BEEN CAUSED OR DIRECTED BY HIS EMPLOYER TO VIOLATE THE PROVISIONS OF THIS SECTION.

534W-1.

(A) THE PROVISIONS OF § 534W OF THIS ARTICLE DO NOT APPLY TO:

(1) ANY ESTABLISHMENT WHICH OFFERS SERVICE AS ITS PRIMARY BUSINESS;

(2) ANY BUSINESS IF IT DOES NOT HAVE MORE THAN SIX EMPLOYEES ON ANY ONE SHIFT ON SUNDAY. IN ADDITION TO THESE SIX PERSONS, THE BUSINESS MAY ALSO HAVE TWO ADDITIONAL PERSONS PERFORMING SECURITY DUTIES;
