It is by them considered that the Sher of Kent County immediately  
take of the said John Buhitt & put him in the pillory for one hour  
and when the hour is fully expired, according to custome; the said Sher  
is ord<sup>d</sup> to take of the said John to the Whipping post, & there to Give him  
fifteen lashes upon the bare back) w<sup>ch</sup> says one as above *Sc.*
