of Kent and according to the forme of those laws and orders shall be  
done. Wee have also constituted you or any four or more of you  
of which you the said Mr. Wm. Frisby Mr. Elias King Capt. John Whitting  
or Mr. Charles Hyndon Capt. Thomas Kingd and Mr. John Saller or  
one of you shall always be one of the Commissioners to enquire by the  
oath of good and lawfull men of your County and of all manner  
of felonies witchcrafts Enchantments Sorceries Magick Artshippes  
forfallings Entropings and Exorsions Whatsoever and of all and  
singular other Misdoods and offences of which Justices of the peace in  
our Kingdom of England may or ought lawfully to Enquire by whom  
soever or whatsoever done or perpetrated or which shall hereafter  
happen to be done or perpetrated in the County and against the laws  
and orders of this our province, provided that you proceed not in any of  
the cases aforesaid to take life or member but that in every such case  
you send the Prisoners with their indictments and the whole Matter  
depending before you to the next provincial Court to be holden for  
this province wheresoever or wheresoever holden there to be tryed  
And further we do hereby authorize and Empower you to issue  
out writts proceffe and Attachments and hold pleas of Oyer and  
Terminar of all Actions of trespass against the forme of any Law  
or Statutes of our Kingdom of England or the province and all  
Actions of trespass quare Clausum Regit All Actions of Debt and  
Detinere Turtrover and replevine for any Sum or Sums of 100.  
Money goods wares or Merchandizes All Actions of Trespass upon  
the Case for money tobacco goods wares or Merchandizes or upon note  
book or Account And all other personall Actions of what Nature or  
kind soever (titles of Land always excepted and forspized) And after  
Judg. Execution to award in all causes civil to be tryed according  
to the laws orders and reasonable Customs made and provided in this  
our province of Maryland. In which causes civil to be tryed (ex-  
cepting as before excepted) we do constitute ordaine and Appoint you  
the severall and respective persons aforesaid to be Judges at aforesaid and there-  
fore we Command you that you diligently intend the keeping of the  
said Laws and orders and all and singular the premises and that  
at certain days appointed by Act of Assembly in such cases made  
and provided And at the place where you or any four or more of you  
as aforesaid shall in that behalf Appoint you make inquiry upon the  
premises and perform and full fill the same in form aforesaid doing therein  
what to Justice appertaineth according to the laws and Customs aforesaid  
And therefore we Command the Sheriff of our said County by virtue of this  
presents that at the place and on the days aforesaid which you or any
