- (2) PAY TO THE BOARD AN APPLICATION FEE:
- (I) OF \$50 FOR A GENERAL LICENSE TO PRACTICE DENTISTRY OR A TEACHER'S LICENSE TO PRACTICE DENTISTRY;
- (II) OF \$15 FOR A LIMITED LICENSE TO PRACTICE DENTISTRY;
- (111) OF \$25 FOR A GENERAL LICENSE TO PRACTICE DENTAL HYGIENE; OR
- (IV) SET BY THE BOARD FOR A TEACHER'S LICENSE TO PRACTICE DENTAL HYGIENE.
- (B) ADDITIONAL REQUIREMENTS -- LIMITED LICENSE TO PRACTICE DENTISTRY.

IN ADDITION TO THE OTHER REQUIREMENTS OF THIS SECTION, AN APPLICANT FOR A LIMITED LICENSE TO PRACTICE DENTISTRY SHALL SUBMIT TO THE BOARD A WRITTEN REQUEST, FROM THE HOSPITAL, SANATORIUM, OR DENTAL SCHOOL TO WHICH THE PRACTICE IS TO BE LIMITED, THAT THE LICENSE BE ISSUED.

- (C) ADDITIONAL REQUIREMENTS -- LICENSE TO PRACTICE DENTAL HYGIENE.
- (1) AT LEAST 30 DAYS BEFORE THE EXAMINATION, AN APPLICANT FOR A GENERAL LICENSE TO PRACTICE DENTAL HYGIENE SHALL SUBMIT THE APPLICATION TO THE BOARD.
- (2) IN ADDITION TO THE OTHER REQUIREMENTS OF THIS SECTION, AN APPLICANT FOR A LICENSE TO PRACTICE DENTAL HYGIENE SHALL SUBMIT TO THE BOARD:
- (I) SATISFACTORY EVIDENCE OF GRADUATION FROM AN APPROVED SCHOOL FOR DENTAL HYGIENISTS; AND
- (II) ANY OTHER CREDENTIALS THAT THE BOARD REQUIRES.
