

(h) (1) Every business entity, including an individual, upon submitting a bid or otherwise applying for a contract with the State, or any county or other subdivision of the State, shall submit ~~OR--SHALL--HAVE SUBMITTED--TO--THE--PROCURING--AGENCY--WITHIN--THE--PRECEDING--12 MONTHS~~ an affidavit stating, to its best knowledge, whether it or [(1)] any of its officers, directors, or partners, or [(2)] any of its employees WHO ARE directly involved in obtaining contracts with the State, or WITH any county or other subdivision of the State, has been convicted of bribery, attempted bribery, or conspiracy to bribe under the laws of any state or OF THE federal government.

(2) THE REQUIREMENTS OF THIS SUBSECTION SHALL BE SATISFIED IF THE AFFIDAVIT:

(I) INCORPORATES BY REFERENCE THE STATEMENTS CONTAINED IN AN AFFIDAVIT FILED WITH THE SAME PROCUREMENT AGENCY WITHIN THE PREVIOUS 12 MONTHS PURSUANT TO THE REQUIREMENTS OF THIS SECTION; AND

(II) STATES THAT THOSE STATEMENTS REMAIN ACCURATE.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1981.

(Senate Bill 290)

AN ACT concerning

Procurement of Architectural and Engineering Services -  
Transportation Agencies and General Using Authorities

FOR the purpose of ~~providing an additional ground~~ altering the grounds for waiving certain competitive procedures that are required for awarding contracts.

BY repealing and reenacting, with amendments,
