## 4-309. TERM AND RENEWAL OF LICENSES.

## (A) TERM OF LICENSE.

- (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBSECTION, A LICENSE EXPIRES ON THE APRIL 1 AFTER ITS EFFECTIVE DATE, UNLESS THE LICENSE IS RENEWED FOR A 1-YEAR TERM AS PROVIDED IN THIS SECTION.
- (2) A LIMITED LICENSE TO PRACTICE DENTISTRY EXPIRES ON THE FIRST ANNIVERSARY OF ITS EFFECTIVE DATE.
- (3) A TEACHER'S LICENSE TO PRACTICE DENTISTRY OR A TEACHER'S LICENSE TO PRACTICE DENTAL HYGIENE EXPIRES ON THE EARLIER OF:
- (I) THE APRIL 1 AFTER ITS EFFECTIVE DATE, UNLESS THE LICENSE IS RENEWED FOR A 1-YEAR TERM AS PROVIDED IN THIS SECTION; OR
- (11) THE DATE WHEN THE LICENSEE CEASES TO BE A FULL-TIME FACULTY MEMBER AT THE INSTITUTION NAMED ON THE LICENSE.

## (B) RENEWAL NOTICE.

AT LEAST 1 MONTH BEFORE A GENERAL LICENSE TO PRACTICE DENTISTRY, A TEACHER'S LICENSE TO PRACTICE DENTISTRY, A GENERAL LICENSE TO PRACTICE DENTAL HYGIENE, OR A TEACHER'S LICENSE TO PRACTICE DENTAL HYGIENE EXPIRES, THE BOARD SHALL SEND TO THE LICENSEE, BY FIRST CLASS MAIL TO THE LAST KNOWN ADDRESS OF THE LICENSEE, A RENEWAL NOTICE THAT STATES:

- (1) THE DATE ON WHICH THE CURRENT LICENSE EXPIRES;
- (2) THE DATE BY WHICH THE RENEWAL APPLICATION MUST BE RECEIVED BY THE BOARD FOR THE RENEWAL TO BE ISSUED AND MAILED BEFORE THE LICENSE EXPIRES; AND
