- (I)--THE--PLAT--SHOWS-A-SUBDIVISION-CREATED PRIOR-TO-JANUARY-17-1970;-AND
- (II)--A-LOT--IN--THE--PLAT--SUBDIVISION--IS GRANTED--AND--A--REFERENCE--TO-THE-GRANT-EXISTS-IN-A-DEED-OF RECORD-
- (2)--THE-CLERK-OF-THE-CIRCUIT-COURT-FOR--CAROLINE COUNTY--SHALL--MAINTAIN--A--SEPARATE--PLAT--BOOK--FOR--PLATS RECORDED-UNDER-THIS-SECTION-
- (3)--REFERENCE-TO--A--PLAT--RECORDED--UNDER--THIS SECTION-MAY-NOT-BY-ITSELF-BE-CONSIDERED-A-DESCRIPTION-OF-THE PROPERTY-SUFFICIENT-TO-IDENTIFY-IT-WITH-REASONABLE-CERTAINTY WITHIN-THE-MEANING-OF-\$-4-101-OF-THIS-ARTICLE-

- (I) IT IS SIGNED AND DATED PRIOR JANUARY 1, 1970; AND
- **GENERAL** (II) ITS--GENERAL--LOCATION THE THE PROPERTY CAN BE DETERMINED BY REFERENCE TO LOCATION OF THE PLAT: AND
- (III) THE PERSON OFFERING THE PLATFOR APPENDS A VERIFIED STATEMENT THAT IT IS THE RECORDING ORIGINAL PLAT, TO THE BEST OF THE OFFERER'S KNOWLEDGE. INFORMATION AND BELIEF.
- (2) THE RECORDING OF PLATS UNDER THIS SUBSECTION SHALL NOT BE CONSTRUED AS THE CREATION OR ESTABLISHMENT OF A OR COMPLIANCE WITH SUBDIVISION ANY OTHER RULES REGULATIONS APPLICABLE TO SUBDIVISIONS.
- [(j)] (K) This section does not apply in Allegany, Harford, Montgomery, Prince George's, Dorchester, and Talbot counties, except to the extent any of these counties is expressly mentioned in this section.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1981.
