{j} (1) Notwithstanding any other provisions of this section in Worcester County, the holder of a Class B, (on-sale - hotels and restaurants) beer, wine and liquor license or Class B, (on-sale - hotels and restaurants) beer and light wine license under this article, by making application in the regular manner and paying the usual fee may obtain [an] additional Class B, (on-sale - [motels] HOTELS and restaurants) beer, wine and liquor or Class B, (on-sale - hotels and restaurants) beer and light wine licenses for premises used and occupied as a bona fide restaurant, as may be defined by the rules and regulations of the board of liquor license commissioners for Worcester County, provided that said restaurant has a minimum capital investment of \$150,000.00 for restaurant facilities, which sum shall not include the cost of land or buildings, and has a minimum seating capacity of 125 persons. Nothing contained herein shall permit the issuance of more than a
