3. TECHNICAL AND MANAGEMENT ADVICE AND ASSISTANCE AS NECESSARY UNDER THE CIRCUMSTANCES; OR
4. A DEMONSTRATION ENERGY PROJECT THAT IS OF HIGH PRIORITY AND BROAD PUBLIC APPLICATION; OR
5. THE UTILIZATION OF LAND OWNED BY A STATE AGENCY FOR THE ESTABLISHMENT OF A DEMONSTRATION ENERGY PROJECT ON AGREEMENT WITH THE STATE AGENCY AND IN CONSULTATION WITH THE LOCAL GOVERNING BODY IN WHOSE JURISDICTION THE LAND IS SITUATED;
