- (a) The State Board shall establish a State committee on the school bus formula that shall consist of representatives from all areas of school transportation.

IF THE AMOUNT THAT IS APPROPRIATED TO A COUNTY UNDER THIS SUBSECTION IN A FISCAL YEAR IS MORE THAN THE ACTUAL COST OF PROVIDING STUDENT TRANSPORTATION SERVICES THAT COUNTY, THE -- COUNTY-MAY-APPLY-THE-EXCESS-MONEY-TO-ANY OTHER-COSTS-OF-OPERATING-PUBLIC-SCHOOLS- A COUNTY BOARD OR BOARD OF SCHOOL COMMISSIONERS OF BALTIMORE CITY MAY APPLY ANY EXCESS FUNDS TO COSTS OF PUPIL TRANSPORTATION IN SUBSEQUENT YEARS. NONE OF THESE FUNDS MAY BE PAID TO OR CLAIMED BY ANY SUBDIVISION, NOR MAY ANY OF THESE FUNDS BE REVERTED TO ANY SUBDIVISION. A COUNTY BOARD OR THE BOARD OF SCHOOL COMMISSIONERS OF BALTIMORE CITY MAY NOT TRANSFER STATE REVENUES FROM THE STUDENT TRANSPORTATION CATEGORY ANY OTHER CATEGORY AS A RESULT OF THIS SECTION.
