- (2) LIQUID WASTE RESULTING FROM THE OPERATION OF THE FIRST CYCLE SOLVENT EXTRACTION SYSTEM, OR ITS EQUIVALENT, AND THE CONCENTRATED WASTE FROM SUBSEQUENT EXTRACTION CYCLES, OR THEIR EQUIVALENT, IN A FACILITY FOR REPROCESSING SPENT NUCLEAR REACTOR FUEL; OR
- (3) SOLIDS INTO WHICH LIQUID WASTE, AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, HAS BEEN CONVERTED.
