SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That section(s) of the Annotated Code of Maryland be repealed, amended, or enacted to read as follows:

Article - Agriculture

TITLE 13. GRAIN

SUBTITLE 1. GRAIN STORAGE INDEMNITY FUND

13-101.

- (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.
- (B) "DEPARTMENT" MEANS THE MARYLAND DEPARTMENT OF AGRICULTURE.
- (C) "FULL MARKET VALUE" MEANS THE VALUE REQUIRED BY LAW TO BE USED BY INSURANCE UNDERWRITERS IN PAYING FOR LOSSES OF COMMODITIES INSURED FOR THEIR CASH VALUE.
- (D) "FUND" MEANS THE MARYLAND GRAIN STORAGE INDEMNITY FUND.
- (E) "GRAIN" MEANS CORN, WHEAT, RYE, OATS, BARLEY, SORGHUM, AND SOYBEANS AND SUNFLOWERS.
- (F) "GRAIN DEALER BUYER" MEANS ANY PERSON WHO IS LICENSED-BY-THE-STATE-OR-FEDERAL-GOVERNMENT-AND-ENGAGED-IN THE-BUGINESS-OF-BUYING,--RECEIVING,--SELLING,-EXCHANGING, WAREHOUSING,-NEGOTIATING,-OR-SOLICITING-THE-SALE,--RESALE, EXCHANGE,-OR-TRANSFER-OF-ANY-GRAIN-PURCHASED-FROM-A-PRODUCER OR-HIS-AGENT-OR-REPRESENTATIVE, OR-HAS-RECEIVED-GRAIN-ON GONSIGNMENT-FROM-A-PRODUCER-OR-HIS-AGENT-OR-REPRESENTATIVE, OR-HAS-RECEIVED-GRAIN-TO-BE-HANDLED-ON-A-NET-RETURN-BASIS FROM-THE-PRODUCER-OR-HIS-AGENT-OR-REPRESENTATIVE PURCHASES MORE THAN 25,000 BUSHELS OF GRAIN IN 1 YEAR FOR USE IN ANY BUSINESS.
- (G) (1) "LOSS" MEANS ANY MONETARY LOSS TO A PRODUCER WHICH IS OF AN EXTRAORDINARY NATURE INCLUDING BANKRUPTCY, EMBEZZLEMENT, THEFT, OR FRAUD.
- (2)--"LOSS"--INGLUDES--BANKRUPTGY,--EMBEZZLEMENT, THEFT,-OR-FRAUD-
- (H) "PRODUCER" MEANS ANY PRODUCER GROWER OF GRAIN.
