

(ii)--IS AUTHORIZED TO DRAFT SPECIFICATIONS FOR, NEGOTIATE, OR EXECUTE A CONTRACT WHICH COMMITS THE STATE, ANY OF ITS SUBDIVISIONS, OR THE AGENCY TO EXPEND IN EXCESS OF \$10,000 OR IS IN A MANAGERIAL OR POLICYMAKING POSITION AS DETERMINED BY THE CHAIRMAN OF THE AGENCY.

(b)--"REGISTRANT" MEANS ANY PERSON REQUIRED TO REGISTER PURSUANT TO THIS SECTION.

(b)--A PERSON WHO COMPENSATES ONE OR MORE REGISTRANTS, REASONABLY BELIEVES THAT ALL EXPENDITURES REQUIRING REGISTRATION ARE REPORTED BY A REGISTRANT, AND ENGAGES IN NO OTHER ACT WHICH WOULD REQUIRE REGISTRATION SHALL BE EXEMPT FROM THE OPERATION OF THIS SECTION EXCEPT FOR THE PROVISIONS OF SUBSECTION (c).

(c)--EVERY EMPLOYER OF A REGISTRANT SHALL FURNISH A WRITTEN AND SIGNED AUTHORIZATION TO ACT WHICH SHALL BE FILED WITH THE BICOUNTY AGENCY INVOLVED AND WITH THE STATE ETHICS COMMISSION BY THE REGISTRANT AT THE TIME OF REGISTRATION. IF THE EMPLOYER IS A CORPORATION, ANY AUTHORIZED OFFICER OR AGENT WHO IS NOT THE REGISTRANT SHALL FURNISH AND SIGN THE WRITTEN AUTHORIZATION. THE AUTHORIZATION SHALL INCLUDE THE FULL AND LEGAL NAME AND BUSINESS ADDRESS OF THE EMPLOYER AND THE REGISTRANT, THE PERIOD OF TIME DURING WHICH THE REGISTRANT IS AUTHORIZED TO ACT, UNLESS SOONER TERMINATED, AND THE PROPOSAL OR SUBJECT UPON WHICH THE EMPLOYER IS REPRESENTED.

(d)--(1) EXCEPT AS EXEMPTED BY SUBSECTION (b), THE FOLLOWING PERSONS SHALL REGISTER WITH THE EXECUTIVE DIRECTOR OF THE BICOUNTY AGENCY INVOLVED AND WITH THE STATE ETHICS COMMISSION:

(i)--A LOBBYIST;

(ii)--ANY PERSON WHO HAS EXPENDED \$500 OR MORE FOR COMPENSATION OF ONE OR MORE REGISTRANTS IN A REPORTING PERIOD, AND

(iii)--ANY PERSON WHO EXPENDS \$2,000, INCLUDING POSTAGE, IN A REPORTING PERIOD FOR THE EXPRESS PURPOSE OF SOLICITING OTHERS TO COMMUNICATE WITH ANY OFFICIAL OR EMPLOYEE OF A BICOUNTY AGENCY TO INFLUENCE ANY ACTION OF THE AGENCY.

(2)--NO LATER THAN 5 DAYS AFTER FIRST PERFORMING ANY ACT REQUIRING REGISTRATION UNDER THIS SECTION, EVERY PERSON REQUIRED TO REGISTER PURSUANT TO SUBSECTION (d) SHALL PROVIDE THE FOLLOWING INFORMATION, WHERE APPROPRIATE, ON THE FORM PRESCRIBED BY THE STATE ETHICS COMMISSION PURSUANT TO SECTION 5-103(b):

(i)--THE REGISTRANT'S NAME AND PERMANENT ADDRESS;
