- (D) THE CONDITIONS OF ELIGIBILITY APPLY JOINTLY AND SEVERALLY IN THE CASE OF SPOUSES WHO ARE LIVING TOGETHER, EXCEPT THAT THE DOMICILE REQUIREMENT MAY BE SATISFIED BY EITHER SPOUSE.

- (A) ANY PERSON WHO KNOWINGLY MAKES OR CAUSES TO BE MADE ANY FALSE STATEMENT OR REPORT FOR THE PURPOSE OF INFLUENCING THE ACTION OF THE SECRETARY ON ANY APPLICATION FOR A LOAN OR ANY ACTION OF THE SECRETARY AFFECTING A LOAN ALREADY MADE, IS GUILTY OF A MISDEMEANOR AND ON CONVICTION IS SUBJECT TO A FINE NOT EXCEEDING \$5,000 OR IMPRISONMENT NOT EXCEEDING 2 YEARS OR BOTH.
- (B) ANY MORTGAGOR KNOWINGLY MAKING OR CAUSING TO BE MADE A FALSE STATEMENT OR REPORT, AT THE OPTION OF THE SECRETARY, AND WITHOUT REGARD TO THE COMMENCEMENT OR STATUS OF CRIMINAL PROSECUTION, SHALL BE SUBJECT TO IMMEDIATE ACCELERATION OF THE MORTGAGE ON WHICH HE IS LIABLE.
