A BILL ENTITLED AN ACT TO REPEAL AND REENACT SECTIONS 14.03, 14.09A, 14.22 AND 14.23 OF THE TALBOT COUNTY CODE PERTAINING TO THE TALBOT COUNTY SANITARY DISTRICTS BY PROVIDING FOR ADOPTION OF STANDARDS FOR INSTALLATION AND TYPES OF SEWERAGE SYSTEMS BY MOTION OF THE COUNTY COUNCIL; PROVIDING REQUIREMENTS FOR EXTENSION OF THE COUNTY'S FACILITIES; AND CHANGING THE TERM HOOKUP CHARGES TO READY TO SERVE CHARGES.

A BILL ENTITLED AN ACT TO COMPREHENSIVELY REVISE AND AMEND THE TALBOT COUNTY ZONING ORDINANCE CHANGING REQUIREMENTS FOR COMPUTATION OF AREA FOR NON-CONFORMING LOTS OF RECORD; INCLUDING MARINE TRAFFIC AS A CONSIDERATION OF THE BOARD OF APPEALS IN GRANTING SPECIAL EXCEPTIONS; MODIFYING THE PROCEDURE FOR AMENDING THE ZONING TEXT; CHANGING THE DEFINITIONS OF HOME OCCUPATION AND LOT; [[PROVIDING FOR RAISING OF POULTRY AS A PERMITTED USE IN A-1 ZONE WITH CERTAIN MINIMUM REQUIREMENTS]]; INCLUDING GAME COURTS AS AN ACCESSORY USE OR STRUCTURE IN A-1, W-2, AND V-1 ZONES; MODIFYING THE REQUIREMENTS FOR ROADSIDE STANDS IN A-1 ZONES; MODIFYING THE USE OF COMMERCIAL GREENHOUSES AND NURSERIES IN THE A-2 ZONE; ADDING GENERAL PROVISIONS FOR BULLETIN BOARDS, DEVELOPMENT SIGNS [[AND EMERGENCY USE OF MOBILE HOMES]]; ADDING SALVAGE YARDS AS A NON-CONFORMING USE; ADDING NEW DEFINITIONS FOR COMMERCIAL AND PRIVATE KENNELS, AND QUASI-PUBLIC STRUCTURES; [[ADDING MOBILE HOMES AS AN ACCESSORY USE UNDER CERTAIN CONDITIONS IN A-1, A-2, A-5 and A-10 ZONES]]; ADDING PIERS AS AN ACCESSORY USE IN W-2 ZONES; PROVIDING FOR SITE PLAN REVIEW IN CERTAIN CASES; ADDING FRONT LOT LINE REQUIREMENTS IN V-1 AND V-2 ZONES;
