IN THIS SECTION, "ARMED FORCES" MEANS THE ARMED FORCES OF THE UNITED STATES.

(B) CLERKS OF COURT.

A CLERK OF COURT SHALL PROVIDE WITHOUT CHARGE:

- (1) A COPY OF ANY PAPER OR RECORD IN THE CLERK'S OFFICE THAT IS REQUESTED BY A FORMER ARMED FORCES MEMBER, IN PERSON, OR BY THE UNITED STATES GOVERNMENT, IF THE COPY IS TO BE USED IN CONNECTION WITH A CLAIM OF THE MEMBER AGAINST THE UNITED STATES GOVERNMENT;
- (2) A COPY OF A MARRIAGE RECORD OF A FORMER ARMED FORCES MEMBER THAT IS REQUESTED BY THE MEMBER; AND
- (3) ANY COPY OF A MARRIAGE RECORD OF A FORMER ARMED FORCES MEMBER OR OF A SURVIVING SPOUSE OR CHILD OF THE MEMBER THAT IS REQUESTED, IF THE COPY IS TO BE USED IN CONNECTION WITH A CLAIM FOR A DEPENDENT OR BENEFICIARY OF THE MEMBER.
 - (C) DEPARTMENT OF HEALTH AND MENTAL HYGIENE.

THE DEPARTMENT OF HEALTH AND MENTAL HYGIENE SHALL PROVIDE WITHOUT CHARGE:

- (1) A COPY OF A BIRTH CERTIFICATE OR MARRIAGE RECORD OF A CURRENT OR FORMER ARMED FORCES MEMBER THAT IS REQUESTED BY THE MEMBER; AND
- (2) ANY COPY OF A BIRTH OR DEATH CERTIFICATE OR MARRIAGE RECORD OF A CURRENT OR FORMER ARMED FORCES MEMBER OR OF A SURVIVING SPOUSE OR CHILD OF THE MEMBER THAT IS REQUESTED, IF THE COPY IS TO BE USED IN CONNECTION WITH A CLAIM FOR A DEPENDENT OR BENEFICIARY OF THE MEMBER.
