(2)--Except-a-bona-fide-employee-in-the-course-of his-employment--a-person-under-21--years-may-only-possess--er have--{upon}--ON-his-person-beer-or-light-wine-of-14-percent of-alcohol-by-volume.

(3)--Any-person-violating--this--subsection--upon conviction-is-guilty-of-a-misdemeanor-and--shall-be-fined-not more--than--\$50.

(f)--(1)--In---Somerset---Caroline---Berkshire, Cecil, Frederick, Washington, Garrett, and Queen--Anne's--counties, it--{shall--be}--IS-unlawful-fer-any-person-under-the-age-of {twenty-one}--21--years to--possess--er--have--{upon}--ON-his person--any--alcoholie--beverages--ether-than-beer-and-light wine,--{and}--fer-any-person--under--{eighteen}--19--years--to possess--er--have--{upon}--ON-his-person-any-alcoholie-beverage, except-a-bona-fide-employee-in-the-course-of-his-employment. Any-miner-having-such-alcoholie-beverages-in-his-possession as aforesaid--shall--upon--conviction-be-deemed-guilty-of-a misdemeanor and--shall-be-fined-not-more-than--fifty--dollars (\$50.00). ---In-Somerset-County, a-person-under-21--years-may only-possess--er--have--{upon}--ON-his-person beer-or-light-wine of-14-percent-alcohol-by-volume.

(g)--(1)--{No}--A-licensee,--proprietor,--er--operator--of any-establishment-dispensing-alcoholie-beverages--{shall}--MAY NOT--permit--the--consumption--er--possession--of--any--alcoholie beverages--ether--than--beer--or--light--wine--by a--person--under the--age--of--{twenty-one}--21--years--or--the--consumption--er
