9-1203. ABOLITION OF EXISTING WATER AND SEWER AUTHORITY AND SANITARY DISTRICT OR COMMISSION -- REQUIRED.

IF THE COUNTY COMMISSIONERS CREATE A DEPARTMENT OF PUBLIC FACILITIES AND SERVICES THAT INCLUDES WATER AND SEWERAGE FUNCTIONS, THE COUNTY COMMISSIONERS SHALL ABOLISH:

(1) ANY WATER OR SEWER AUTHORITY CREATED BY THE COUNTY COMMISSIONERS OR BY PUBLIC LOCAL LAW ENACTED BY THE GENERAL ASSEMBLY UNDER SUBTITLE 9 OF THIS TITLE; AND

(2) ANY SANITARY DISTRICT OR COMMISSION CREATED UNDER SUBTITLE 6 OF THIS TITLE.

9-1204. SAME -- PROVISIONS OF ORDINANCE OF RESOLUTION.

ANY ORDINANCE OR RESOLUTION THAT ABOLISHES A WATER OR SEWER AUTHORITY OR A SANITARY DISTRICT OR COMMISSION SHALL PROVIDE:

(1) THAT ALL PROPERTY, REAL AND PERSONAL, OF ANY WATER OR SEWER AUTHORITY OR SANITARY DISTRICT OR COMMISSION ABOLISHED BY THE ORDINANCE OR RESOLUTION SHALL BE TRANSFERRED TO CALVERT COUNTY;

(2) FOR THE RETIRING, REFUNDING, REFINANCING, TRANSFER, OR ASSUMPTION OF ANY EXISTING APPLICABLE OUTSTANDING BONDED INDEBTEDNESS, AND FOR COUNTY ASSUMPTION OF ALL EXISTING ASSETS AND LIABILITIES OF THE WATER OR SEWER AUTHORITY OR SANITARY DISTRICT OR COMMISSION THAT IS ABOLISHED, SUBJECT TO AN AUDIT BY A CERTIFIED PUBLIC ACCOUNTANT OF THE ASSETS AND LIABILITIES TO BE ASSUMED;
