send to each public service company affected a statement setting forth the amount due and payable by, or the amount standing to the credit of, the public service company. Any amount owing by any public service company shall be paid not later than 30 days following the date the statement is received. Any amount standing to the credit of any public service company shall be refunded by the Commission or, the option of the public service company, applied as a credit against any succeeding payment due. (c) The Secretary shall administer the Fund. The Fund is subject to the provisions for financial management and budgeting established by the Department of Budget and Fiscal Planning.
