[Within 60 days after it adopts an amendment or supplement to its charter or other instrument under which it is organized, a foreign corporation qualified to do business in this State shall file with the Department an officially certified statement which specifies the date and record reference of the amendment or supplement.] EVERY-FOREIGN CORPORATION-QUALIFIED-TO-DO-BUSINESS-IN-THIS-STATE-WHICH:

- (1)--MERGES-INTO-ANY-OTHER-CORPORATION;
- 42) -- CONSOLIDATES INTO ANY OTHER CORPORATION;
- (3)--DISSOLVES;-OR
- (4)--ADOPTE-ANY-OTHER-AMENDMENT-OR-SUPPLEMENT-TO
  ITS-CHARTER-OR-OTHER-INSTRUMENT-UNDER-WHICH-IT-WAS-ORGANIZED
  THAT--CHANGES--ITS--NAME--OR-TERMINATES-ITS-EXISTENCE,-SHALL
  FILE-WITH--THE--DEPARTMENT--WITHIN--60--DAYS--A--CERTIFICATE
  EVIDENCING--SUCH--ACTION,--AND--SPECIFYING--THE-DATE-OF-SUCH
  ACTION,-EXECUTED-BY-THE--OFFICIAL--OF--THAT--PLACE--WHO--HAS
  CUSTODY-OF-THE-PERTINENT-RECORDS:
- (A) A FOREIGN CORPORATION THAT IS QUALIFIED TO DO BUSINESS IN THIS STATE SHALL FILE AN OFFICIALLY CERTIFIED STATEMENT WITH THE DEPARTMENT WITHIN 60 DAYS AFTER THE CORPORATION:
  - (1) MERGES INTO ANOTHER CORPORATION;
  - (2) CONSOLIDATES WITH ANOTHER CORPORATION;
  - (3) DISSOLVES; OR
- (4) AMENDS OR SUPPLEMENTS THE INSTRUMENT UNDER WHICH IT WAS ORGANIZED TO CHANGE THE NAME OF THE CORPORATION OR TERMINATE ITS EXISTENCE.
  - (B) THE OFFICIALLY CERTIFIED STATEMENT SHALL:
- (1) BE EXECUTED BY THE OFFICIAL OF THAT PLACE WHO HAS CUSTODY OF THE PERTINENT RECORD; AND
- (2) INCLUDE THE ACTION TAKEN AND THE DATE THE ACTION WAS TAKEN.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1982.
