that the hearing be publicized in certain newspapers at a certain time prior to the date of the hearing; defining a certain term; providing that the hearing be organized in order that certain groups receive adequate notice and an opportunity to present statements; and requiring the issuance of a report to provide notice of documents pertaining to the subject matter of a public hearing.

## BY adding to

Article 44A - Housing Authorities Section 8A(f) Annotated Code of Maryland (1980 Replacement Volume and 1981 Supplement)

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That section(s) of the Annotated Code of Maryland read(s) as follows:

- (F) (1) IN THIS SECTION "ASSISTED FAMILY HOUSING" HAS THE DEFINITION PROVIDED BY THE MONTGOMERY COUNTY GOVERNMENT.
- (2) THE HOUSING OPPORTUNITIES COMMISSION SHALL HOLD A PUBLIC HEARING ON ITS PROPOSED ASSISTED FAMILY HOUSING.
- (3) THE PUBLIC HEARING SHALL BE PUBLICIZED BY A DISPLAY ADVERTISEMENT IN 2 NEWSPAPERS OF GENERAL CIRCULATION IN MONTGOMERY COUNTY AT LEAST 15 DAYS PRIOR TO THE PUBLIC HEARING.
- UBSEQUENT TO THE PUBLIC HEARING, SHALL ISSUE A REPORT OF ITS FINDING AND CONCLUSIONS ON ITS PROPOSED ASSISTED FAMILY HOUSING WHICH WAS THE SUBJECT OF THE PUBLIC HEARING.
