- [(a) Prior to October 1st of each calendar year, the commission shall prepare and submit to the governing body of each county in the sanitary district and the county executive of Montgomery County a six-year projected program of capital improvements with respect to water, sanitary sewerage, and storm drainage facilities, the same hereinafter being referred to as the commission's capital improvements program. The commission's capital improvements program shall include, for each major water, sewer, and storm drainage project, a statement of the objectives of the several projects or individual programs and their relationship to the long-range development plans of the respective county governing bodies, as they shall have been designated to the commission by the county governing body.
