Any person under the age of twenty-one (21) years violating the provisions of this subtitle shall be deemed guilty of a misdemeanor, and upon a conviction thereof in any court of competent jurisdiction, shall be sentenced to pay a fine of not less than \$25.00 nor more than \$100.00 or imprisoned in jail for a period not exceeding ten days or both fined and imprisoned in the discretion of the court. Any such person who is under the age of 18 years shall be within the jurisdiction of the juvenile courts of the said counties.]

- (a) Any person who obtains any spirituous or fermented liquors from any other person licensed to sell them for any minor or person under age 21, except that the age shall be 18 years for beer or light wine, knowing him to be such, to be drunk by the minor or person under age 21, except that the age shall be 18 years for beer or light wine, is guilty of a misdemeanor, and upon conviction shall be fined not less than \$20 nor more than \$50, or imprisoned in jail for not less than 30 days nor more than 90 days, or be both fined and imprisoned in the discretion of the court.
