- (B) (1) A BUYER DESCRIBED IN § 14-12B-01(B)(1)(I) OF THIS SUBTITLE MAY CANCEL A HEALTH CLUB SERVICES AGREEMENT WITHIN 3 BUSINESS DAYS AFTER RECEIPT OF A COPY OF THE AGREEMENT BY NOTIFYING THE HEALTH CLUB IN WRITING. WRITTEN NOTIFICATION SHALL BE DELIVERED IN PERSON OR BY CERTIFIED OR REGISTERED MAIL, AND IF MAILED SHALL BE POSTMARKED BY MIDNIGHT OF THE THIRD BUSINESS DAY.
- (2) THE HEALTH CLUB FACILITY SHALL CONSPICUOUSLY DISCLOSE IN THE HEALTH SERVICES AGREEMENT THE BUYER'S RIGHT TO CANCEL WITHIN 3 BUSINESS DAYS.
- (3) IF THE BUYER CANCELS WITHIN 3 BUSINESS DAYS, THE HEALTH CLUB FACILITY SHALL REFUND ANY DEPOSIT, DOWN PAYMENT, OR PAYMENT ON THE AGREEMENT.
