The Joint Budget and Audit Committee shall give detailed and systematic attention and study to all the functions of budget analysis and review, capital budget study, fiscal policy, fiscal research, legislative post-audit, departmental operation and efficiency within the State government, and any other problems, matters, or procedures covered by or related to the provisions of this subtitle and the several officers and employees engaged thereunder. The committee shall meet and organize promptly after appointment, and thereafter it shall meet as often as necessary in its judgment to discharge its duties and accomplish its functions with celerity and efficiency.
