

Article 88D - State Lottery

~~THE COMMISSION AND THE DIRECTOR SHALL PROVIDE FOR AT LEAST 2 INSTANT LOTTERY GAMES TO BE HELD DURING THE FISCAL YEAR ENDING JUNE 30, 1984.~~

(A) THE COMMISSION AND THE DIRECTOR SHALL PROVIDE FOR A "LOTTO" GAME TO BE CONDUCTED ON A WEEKLY BASIS. THE COMMISSION SHALL ISSUE REGULATIONS TO PROVIDE FOR THE OPERATION OF THE GAME.

(B) A "LOTTO" GAME IS A GAME OF CHANCE IN WHICH THE PLAYERS SELECT A CERTAIN NUMBER OF SQUARES, USUALLY DESIGNATED BY NUMBERS, FROM A GRID AND ATTEMPT TO MATCH AN EQUAL NUMBER OF RANDOMLY DRAWN NUMBERS. PRIZES ARE AWARDED BASED ON A PARI-MUTUEL BETTING STRUCTURE.

(C) (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS ARTICLE, ALL RECEIPTS FROM "LOTTO" GAMES SHALL BE PLACED IN A SPECIAL SEPARATE ACCOUNT OF THE COMPTROLLER. AFTER PAYMENT OF PRIZES AND OTHER EXPENSES OF OPERATING THE "LOTTO" GAMES, THE COMMISSION AND THE DIRECTOR COMPTROLLER SHALL DISTRIBUTE THE REMAINING PROCEEDS OF THE GAMES TO THE POLITICAL SUBDIVISIONS OF THE STATE ON A QUARTERLY BASIS.

~~(2) THE SHARE OF EACH SUBDIVISION SHALL BEAR THE SAME PROPORTION TO THE TOTAL DISTRIBUTED THAT THE TOTAL REVENUE FROM LOTTERY OPERATIONS RAISED IN THAT SUBDIVISION IN THE PREVIOUS FISCAL QUARTER BEARS TO THE TOTAL REVENUE FROM STATEWIDE LOTTERY OPERATIONS IN THAT QUARTER.~~

(2) THE AMOUNT TO BE DISTRIBUTED EVERY 3 MONTHS TO EACH POLITICAL SUBDIVISION SHALL BE THE SUM OF THE AMOUNTS DETERMINED AS FOLLOWS:

~~(i) AN AMOUNT FOR EACH SUBDIVISION WHICH SHALL BE A SHARE OF 50 PERCENT OF THE REVENUES TO BE DISTRIBUTED BEARING THE SAME PROPORTION TO 50 PERCENT OF THE REVENUES AS THE TOTAL AMOUNT OF RECEIPTS FROM "LOTTO" GAMES IN THAT SUBDIVISION DURING THAT 3 MONTH PERIOD BEARS TO THE TOTAL OF STATEWIDE RECEIPTS FROM "LOTTO" GAMES IN THAT 3 MONTH PERIOD, AND~~

~~(ii) AN AMOUNT FOR EACH SUBDIVISION WHICH SHALL BE A SHARE OF 50 PERCENT OF THE REVENUES TO BE DISTRIBUTED BEARING THE SAME PROPORTION TO 50 PERCENT OF THE REVENUES AS THE TOTAL AMOUNT OF RECEIPTS FROM LOTTERY GAMES, EXCLUDING "LOTTO" GAMES, IN THAT SUBDIVISION DURING THE 3 MONTH PERIOD BEARS TO THE TOTAL OF STATEWIDE RECEIPTS FROM LOTTERY GAMES, EXCLUDING "LOTTO" GAMES, IN THAT 3 MONTH PERIOD.~~

(3) DISTRIBUTIONS PURSUANT TO THIS SUBSECTION SHALL BE MADE WITHIN 30 DAYS OF THE END OF THE APPLICABLE 3 MONTH PERIOD, AND IF A DISTRIBUTION IS MADE BASED ON ESTIMATED DATA, IT
