AN ACT concerning

Retail Sales Tax - Diesel Fuel - Reclamation of Certain Land Mined for Coal

FOR the purpose of creating an exemption from the retail sales tax for sales of diesel fuel for the reclamation of certain land that has been mined for coal by certain methods.

BY adding to

Article 81 - Revenue and Taxes Section 326(d-1) Annotated Code of Maryland (1980 Replacement Volume and 1982 Supplement)

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article 81 - Revenue and Taxes

326.

The tax hereby levied does not apply to the following sales:

(D-1) SALES OF DIESEL FUEL IN-THIS-STATE THAT IS TO BE USED IN THE RECLAMATION OF LAND WHICH HAS BEEN MINED FOR COAL BY MEANS OF STRIP MINING OR OPEN-PIT MINING.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1983.
