- (II) PERSONS OVER 64 YEARS OF AGE TO HARVEST OYSTERS BY HANDTONG OR HANDSCRAPE IN AUTHORIZED AREAS;
- (III) PERSONS OVER 64 YEARS OF AGE TO HARVEST FINFISH FOR COMMERCIAL PURPOSES WITH A SINGLE GILL NETS-UP-T0-400 YARDS NET UP TO 200 YARDS IN LENGTH;
- (IV) PERSONS UNDER 14 AND OVER 64 YEARS OF AGE FOR FINFISH AND CRAB HARVESTING FOR PERSONAL CONSUMPTION PURSUANT TO §§ 4-709 AND 4-804(C).
- (E) (1) A PERSON SHALL APPLY FOR A NEW OR RENEWED TIDAL FISH LICENSE ON THE APPROPRIATE FORM PROVIDED BY THE DEPARTMENT AND SHALL SUBMIT WITH THE APPLICATION THE ANNUAL FEE FOR EACH ACTIVITY FOR WHICH A LICENSE IS SOUGHT.
- (2) THE DEPARTMENT MAY REQUIRE AN APPLICANT TO CERTIFY ON THE APPLICATION FORM THAT THE FACTS SET FORTH IN THE COMPLETED FORM ARE TRUE. THE DEPARTMENT SHALL REQUIRE EACH APPLICANT TO INDICATE ON THE APPLICATION FORM, UNDER PENALTY OF PERJURY, WHETHER THE APPLICANT IS A RESIDENT OF MARYLAND.
- (3) AN APPLICATION FOR A NEW OR RENEWED TIDAL FISH LICENSE AND ACCOMPANYING FEES MAY BE SUBMITTED TO THE DEPARTMENT, OR TO THE CLERK OF THE CIRCUIT COURT IN EACH COUNTY.
- (4) THE DEPARTMENT OR THE COURT CLERK SHALL NOT ACCEPT AN APPLICATION UNLESS IT IS COMPLETE, LEGIBLE, AND CORRECTLY INDICATES THE ACTIVITIES FOR WHICH FEES ARE SUBMITTED WITH THE APPLICATION.
- (5) UPON ACCEPTANCE OF AN APPLICATION FOR A RENEWED LICENSE AND ACCOMPANYING FEES, THE COURT CLERK OR THE DEPARTMENT SHALL ISSUE THE RENEWED LICENSE.
- (6) UPON ACCEPTANCE OF AN APPLICATION AND ACCOMPANYING FEES FOR A NEW TIDAL FISH LICENSE, THE DEPARTMENT OR THE COURT CLERK SHALL GIVE THE APPLICANT A DUPLICATE COPY OF THE APPLICATION, WHICH SERVES FOR NO MORE THAN 30 DAYS AS A TEMPORARY LICENSE TO CONDUCT THE INDICATED ACTIVITIES.
- (7) WITHIN 48 HOURS AFTER A COURT CLERK ISSUES A NEW OR TEMPORARY LICENSE, THE CLERK SHALL FORWARD THE ORIGINAL COPY OF THE APPLICATION TO THE DEPARTMENT. THE CLERKS OF COURT SHALL FORWARD MONTHLY TO THE DEPARTMENT ALL LICENSE FEES, ACCOMPANIED BY A LICENSE REPORT ON A FORM PROVIDED BY THE DEPARTMENT.
- (8) WHENEVER AN APPLICATION IS SUBMITTED TO A COURT CLERK, THE CLERK SHALL CHARGE IN ADDITION TO THE LICENSE FEES A PROCESSING FEE OF \$1.
- (9) THE DEPARTMENT SHALL ISSUE ANY NEW TIDAL FISH LICENSE WITHIN 30 DAYS FROM THE DATE ON THE TEMPORARY LICENSE ISSUED BY THE DEPARTMENT OR THE COURT CLERK. THE DEPARTMENT
