(A) ALL RECEIPTS DESIGNATED FOR THE DAY CARE FACILITIES LOAN ~~FINANCING~~ GUARANTEE FUND SHALL BE PLACED IN THE FUND AND ADMINISTERED BY THE DEPARTMENT INCLUDING:

~~(1) -- REPAYMENTS OF PRINCIPAL OF AND INTEREST ON DIRECT LOANS,~~

~~(2) (1) PREMIUMS FOR GUARANTEEING LOANS; AND~~

(C) IN GUARANTEEING LOANS UNDER THIS SUBHEADING, CONSIDERATION SHALL BE GIVEN TO:

(1) GEOGRAPHIC DISTRIBUTION;

(2) COMMUNITY NEED; AND

(3) COMMUNITY INCOME, WITH PRIORITY GIVEN TO THOSE COMMUNITIES WITH THE LOWEST MEDIAN FAMILY INCOME.
