(A) (1) THE ADMINISTRATION SHALL ANNUALLY SELECT FOR VERIFICATION ON A RANDOM SAMPLE BASIS NOT LESS THAN--1--NOR--MORE THAN 10 PERCENT OF VEHICLE REGISTRATIONS SUBJECT TO THE SECURITY REQUIRED BY THIS SECTION.

(2) THE REGISTERED VEHICLE OWNER SELECTED FOR VERIFICATION SHALL SUBMIT PROOF OF INSURANCE WITHIN 30 DAYS TO THE ADMINISTRATION ON A FORM PRESCRIBED BY THE ADMINISTRATION AND CERTIFIED BY AN INSURER OR AGENT.

(3) THE FAILURE OF A VEHICLE OWNER TO SUBMIT THE REQUIRED PROOF UNDER THIS SECTION WITHIN A 30 DAY PERIOD SHALL BE PRIMA FACIE EVIDENCE THAT THE VEHICLE IS UNINSURED.

(B) (1) THE ADMINISTRATION SHALL PERIODICALLY SELECT FOR VERIFICATION ANY STATEMENT OF THE REQUIRED SECURITY BY A PERSON WHO HAS PREVIOUSLY BEEN CONVICTED OF VIOLATING THE PROVISIONS OF THIS SUBTITLE, OR WHOSE STATEMENTS OF REQUIRED SECURITY HAVE PREVIOUSLY BEEN FOUND TO BE INCORRECT.

(2) THE ADMINISTRATION MAY DETERMINE THE ACCURACY OF INFORMATION RELATING TO PROOF OF REQUIRED SECURITY SATISFYING THE PROVISIONS OF THIS SUBTITLE.
