Article 2B - Alcoholic Beverages
Section 150(c)
Annotated Code of Maryland
(1981 Replacement Volume and 1982 Supplement)

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article 2B - Alcoholic Beverages

150.

(c) (1) In Montgomery County, [effective July 1, 1979,] the board of license commissioners [shall consist] CONSISTS of [five] 5 members, appointed by the county executive, subject to confirmation by the county council.

(2) [Each member of the board serves a term of 4 years, provided, however, that those members serving on the board of license commissioners on July 1, 1979, shall serve the remainder of their terms; any later appointment shall conform to the above stated length of service.] ~~EXCEPT--FOR-3-MEMBERS-APPOINTED-IN-1983,-THE-TERM-OF-A-MEMBER-IS-5-YEARS~~ EACH MEMBER OF THE BOARD SERVES A TERM OF 4 YEARS, EXCEPT THAT THE TERM OF ONE MEMBER WHO IS APPOINTED OR REAPPOINTED TO FILL ONE OF THE TERMS EXPIRING IN 1983 SHALL BE FOR 3 YEARS, AND 4 YEARS THEREAFTER.

{(3)}-(4) Not more than three members of the board shall be members of the same political party.

{(4)}-(5) (4) The board annually shall elect one of its members as chairman.

{(5)}-(6) (5) Three members of the board constitute a quorum for transacting business. At least three members who are present at the voting session must concur in the approval, denial, revocation, suspension, or reclassification of an alcoholic beverage license.
