(d) The State Administrative Board of Election Laws shall divide and transmit the fees received by it from candidates for election as delegates to a national convention OR-A-STATE CONVENTION in equal amounts to the board of each county within the respective congressional district and to the board in Baltimore City for any congressional district wholly or partly therein.

- (a) The total number of delegates and alternate delegates to represent the respective political parties at their respective national conventions shall be ascertained and determined by the governing body of each party and certified to the State Administrative Board of Election Laws not later than the first day of March in each year in which national conventions for the nomination of President and Vice-President are held.
